

Licence and annual subscription agreement

Dynamic Data Analysis Language - standard Entity Framework Core implementation

The DDAL/EF software package includes the source code, library and documentation, and example programs (hereinafter the "Software").

It is conceded under a licence of final use, the property of the rights is not yielded by IMPLEX SASU, which allows a use only according to the terms of the present licence.

IMPLEX SASU reserves all ownership rights not expressly granted to you. You install the media on which the Software is installed on your computer, but which is the property of IMPLEX SASU.

1. LICENCE.

IMPLEX SASU grants you the end-user licence to use a maximum of one copy of the Software for a single user.

A licence key corresponds to a maximum of one copy of the Software. You must pay an annual subscription fee to use the Software. This subscription must be renewed every year.

Under the terms of this licence, you can:

- 1.1. Make an unlimited number of copies with any modifications whatsoever, provided that these copies are only used internally and are not distributed or republished from your computer.
- 1.2. Use and modify the Examples, provided that you do not distribute or republish the Examples, or any modified version of the Examples in the source code template.
- 1.3. Redistribute the software files with your products.

The Software is "in use" when you develop source code that depends on the Software and link your projects to the libraries (original or modified).

2. EXCLUSIONS.

You must not:

- 2.1. Distribute or publish any part of the Software (original or modified) unless you have received written authorization from IMPLEX SASU.
- 2.2. Redistribute the Software as part of a software development library without the written authorization of IMPLEX SASU.
- 2.3. Do not pass on to anyone your annual user subscription number that you have received from IMPLEX SASU.
- 2.4. You may not assign, give, rent, sub-license or transfer the Licensed Software and related documents to third parties without the written permission of IMPLEX SASU.

3. DELIVERY DDAL EF

IMPLEX supplies the following components:

- 1.1 A Docker container hosted on "Docker Hub" that is freely available and requires activation before it can be used. This Docker container is identified as "impl3x/ddal-ef»).
- 1.2 A set of NuGet packages for direct use in hosted C# code. The main NuGet package is identified as "Implex.DDALEF.Interface»).

4. SUBSCRIPTIONS AND RENEWALS.

A 12-month subscription for one user entitles the user to:

- Contractual response from the support team
- Technical support via @mail: support.ddal@implex.fr
- In the case of an incident and reproduction of a bug, a corrective patch will be delivered
- A new version of the product if it is released within 12 months: with all the patches and any improvements.
- As part of the automated annual renewal: at discounted prices linked to the continuity of the subscription.

In the case of subscription renewal being discontinued, if the customer wants to restart the subscription they will have to pay for the resumption of their licence at the list price.

4. COPYRIGHT.

The Software is the intellectual property of IMPLEX SASU and is protected by international copyright laws and treaty arrangements.

5. PATENT PROTECTION.

As legal protection for DDAL and DDAL/EF Core, our partner, a specialist industrial property consultancy, has implemented patent protection for DDAL and DDAL/EF Core.

6. LIMITED WARRANTY

This Software is licensed on an "AS IS" condition. If, for any reason, you are dissatisfied with the Software, delete it from your computer system and destroy all copies of it.

In no case shall IMPLEX SASU be responsible or liable to you for any damages, including lost profits, lost savings or other incidental or consequential damages that result from your use of, or any inability to use, the Software.
